

General Entrance Regulations for Trucks entering the Chemical Park Linz (CPL)

In order to receive the permission to enter the CPL the following conditions have to be fulfilled:

A) Completion of a safety training

A confirmation will be issued at the end of the instruction. It always has to be carried along and has to be presented upon request.

B) Required documents

The driver has to present following documents:

- Valid driving license of the required classes
- Car documents
- Reference number (e.g. order number, delivery note number, etc.) and name of the partner company at CPL

C) Safety regulations for equipment

- All dangerous goods transports have to undergo a check.
- Truck and equipment have to conform to legal requirements (e.g. for dangerous goods transport, tyres, brakes, labels and placards)
- The driver has to bring along equipment to secure loads and is obliged to use it.
- Members of the plant protective force may carry out sample checks.



D) Personal Protective Equipment (PPE)



The driver has to **carry along** the following PPE at entrance and has to **wear it** onsite as from leaving the truck within CPL:



- Long clothes: covering arms, legs and body
- Fluorescent safety vest
- Safety footwear
- Safety helmet
- Safety glasses with side protection
- Safety gloves suitable for the intended use (product)



Additional requirements may be stipulated in the transport contract and will be checked at the loading department.

E) Rules and Restrictions



- **Alcohol is strictly forbidden**
- **No filming or taking pictures**
- **Absolute ban on smoking**



throughout the entire chemical park (**even within the truck**). Excluded are designated, clearly labelled rooms.



- **Obligation to register at the control room:** strictly no admittance to facilities for unauthorized persons, registration and check-out with the shift leader required



- **Explosion hazard in facilities:** therefore no open flames – no activities that produce sparks. In explosive zones it is not allowed to use non-explosion-proof electrical devices or means of communications (e.g. mobile phones).



- **No unauthorized co-driver, children and animals**



Traffic regulations

- Maximum speed allowed: 30 km/h
- Ban on driving when alarm goes off
- Road traffic regulations are to be followed
- Parking only at assigned zones on marked parking areas
- Do not drive on premises where production facilities are located.
- Keep accesses & thoroughfares clear for emergency vehicles



F) Consequences of non-compliance

Failure to follow the entrance conditions will result in no granting permission to enter the chemical park. Violation of the above-mentioned conditions may result in getting a caution (max. two) and/or being banned from site.

I am liable for every loss or damage caused by me violating the above mentioned conditions or by my other culpable behaviour. Knowledge gathered during the stay onsite, are to be treated confidentially and secret. My data collected by the entrance protection system, will be processed electronically and transmitted. I am aware of the dangers of a chemical park. For possible losses and damages the companies of the chemical park are only liable within their insurance coverage.
